

is not a regulation. Each Department within the DoD has a supplement that further defines service specific (i.e. Air Force, Army, Navy/Marines) or agency specific (i.e. DLA) regulations. If the FAR is silent on the guidance for particular issue, and that issue is addressed in the DFARS cite, the DFARS cite supplements the FAR. The FAR is organized so that the general policy is always stated first, followed by the specific policy.
