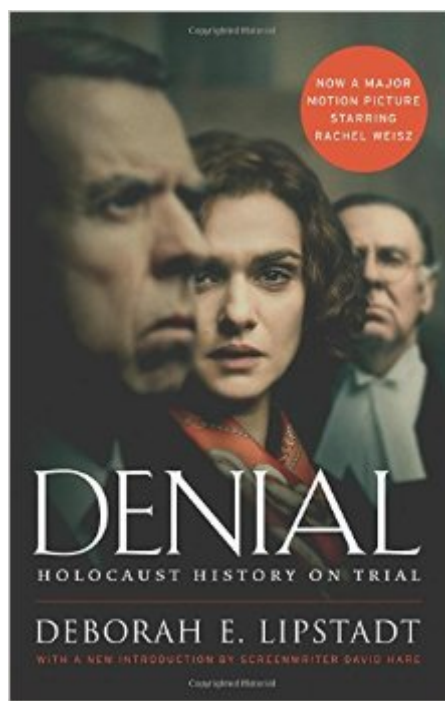

In her acclaimed 1993 book *Denying the Holocaust*, Deborah Lipstadt called David Irving, a prolific writer of books on World War II, "one of the most dangerous spokespersons for Holocaust denial."
